BRIEF DESCRIPTION OF DUTIES

The Lead-MAJCOM for aircraft and mission set will determine the Multi-domain Operations Aviator (MOA) performance tasks as outlined in Master Training Tasks/Task Training Lists associated with Mission Design Series crew positions. Performs perflight and post-flight requirements of aircraft and aircraft systems. Performs duties as an aircrate member on manned aircraft (RPA). Integrates air, space, and cyber domains at the operational level to plan, coordinate, allocate, task, assess, and monitor mission systems to ensure lethal and non-lethal application of airpower. Performs surveillance, combat identification, weapons control, tactical data link management, communications, and airborne network management. Performs mission planning of aircraft and aircraft systems in accordance with aircraft technical orders, applicable Air Force Instructions (AFIs), and Unified Combatant Commands' theater Rules of Engagement (ROE). Detects, analyzes and discriminates between valid and invalid targets using radar systems, electro-optical, low light, infrared full motion video imagery, and ther active or passive target acquisition and tracking systems. May be responsible for terminal guidance of precision guided munitions. Supervises and instructs personnel on the operation, maintenance, repair, and test procedures of airborne and ground based aircraft systems. Establishes, manages, and supervises aircrew training. Coordinates with maintenance, communication technicians, and intelligence units to satisfy unit training requirements, including weapons and tactics programs. Evaluates aircrew academic, inflight performances, and systems capabilities and recommends improvements.

KNOWLEDGE, SKILLS AND ABILITIES (KSAs) REQUIRED FOR THIS POSITION:

- A. Ability to collect and interpret mission data, employ sensors to actively and/or passively acquire, track, and monitor airborne, maritime, and ground objects.
- B. Knowledge of and Ability to support air and ground-based operations to validate targets and threats using various sensors, systems, and munitions to conduct multiple mission sets. Monitor radio communications and analyze intelligence data to direct aircraft position to assist in navigation and fire control planning. Interpret charts, imagery, and video data supporting relay of information to various agencies to provide real-time mission data, threat, and target updates.
- C. Ability to plan and operate datalink operations for the area of responsibility to create a single integrated common operating picture. Compare and report track positions based on flight data. Maintain logs, forms, and database files of aircraft and missions.
- D. Knowledge and Ability to establish and direct aircrew training. Supervise, instruct and evaluate aircrew members.
- E. Skill in developing instructions for equipment operations, maintenance, and troubleshooting, ensuring standardized procedures. Identify training needs, oversee training programs, and validate instructional methods and arrange remedial and continuation training.
- F. Ability to manage operational and maintenance functions. Maintain records, solve complex operational problems, and recommend maintenance and operational enhancements. Advise developers on system operations and maintenance to support acquisition, development, and updates of aircraft systems.

AIR NATIONAL GUARD MEMBERSHIP AND COMPATIBILITY REQUIREMENTS

This vacancy announcement will be for an initial active-duty tour of one (1) to four (4) years. Subsequent tours will be from one (1) to five (5) years. The selected applicant will be placed in Active Guard/Reserve (AGR) military status under Title 32, USC 502(f). The incumbent will participate with the unit of assignment during unit training assemblies and annual training periods. After an applicant is selected for this position, the incumbent will be assigned to **AFSC: 1A174 at the 128 ACCS, Robins AFB, GA**. If a selected applicant's grade is higher than the announced grade of the position (Enlisted Only) the selected applicant may be required to request an administrative reduction to the announced grade of the position. The wearing of the Air Force uniform as prescribed in AFI 36-2903 is required for the incumbent of this position. Acceptance of the position constitutes concurrence with these requirements as conditions of employment. Military Grade Inversion is strictly prohibited in the National Guard AGR Program.

QUALIFICATION REQUIREMENTS

- This opportunity is available to current members of the Active, Reserve, and Guard components of the United States Air Force. All applications will be accepted; however, first consideration will be given to Category I.
- Applicants are assessed into Category I or II:
 - Category I All applicants currently possessing the required Rank, AFSC/Skill Level, and with the Area of Consideration requirements stated above.
 - Category II All other applicants who do not possess the required AFSC/Skill Level and Area of Consideration but meet the rank requirements and the basic AFSC entry requirements IAW ANGI 36-101, the Air Force Officer Classification Directory (AFOCD) or the Air Force Enlisted Classification Directory (AFECD) Attachment 4. Category II applicants are forwarded to the selecting official on request when a selection is not made from the Category I Register.
- The member must continue to progress in upgrading to skill level appropriate for his/her military grade. Members who do not successfully upgrade will be reassigned to a position for which qualified or removed from the AGR program.

OTHER REQUIREMENTS

- Member must meet ALL eligibility criteria in ANGI 36-101.
- Member must meet all entry level requirements outlined in the AFO/ECD.
- Member must comply with standards outlined in DAFI 36-2903, Dress and Personal Appearance
- Member must comply with standards outlined in DAFMAN 36-2905, Physical Fitness Program. To be eligible for entry into the AGR program, a passing score of 75 or better on the fitness test is required.
- Member selected for initial AGR positions must meet the medical standards as outlined in AFI 48-123 prior to assignment.
- A current PHA with associated documentation must be less than 12 months old. Applicants whose PHA is greater than 12 months old will require a current exam as appropriate. Members must also be current in all IMR requirements (i.e. dental, immunizations, etc.)
- Enlisted member must not have been previously separated from active duty or a previous AGR tour for cause.
- Member must have sufficient retainability to obtain 20 years of Active Federal Service for retirement purposes. Individuals selected for AGR tours that cannot attain 20 years of TAFMS prior to reaching mandatory separation must complete a Statement of Understanding.
- Enlisted personnel applying for officer positions must be eligible for commissioning upon application for AGR duty. Assignment to the AGR tour will not become effective until the individual receives a commission in the ANG and as a Reserve of the Air Force and has completed formal training for which an AFSC has been awarded.
- Security Clearance if a Top-Secret security clearance is not held by the member selected for assignment that requires access to top secret information, the member must initiate a security clearance update. The AGR selectee must notify his/her unit security manager to initiate a new security investigation. The HRO/AGR Manager will not issue the AGR orders until the security clearance upgrade is initiated, and the member has a current favorable investigation.
- AGRs and their authorized dependents may be entitled to PCS benefits provided by law IAW the Joint Federal Travel Regulations (JTR)-PCS entitlements. Individuals entitled to PCS entitlements should not leave their HOR until PCS orders are provided.
- IAW ANGI 36-101, AGR Program para 5.7, To be accessed in the AGR program, an individual must not have been previously separated for cause from a previous Reserve Component AGR tour or from any Active Component. Requests for waiver to this policy will be annotated on the AF Form 679 and routed to NGB/A1PP.

- Incomplete application packages (i.e. not within full announcement requirements, failure to explain "yes" answers in Section IV on the NGB 34-1, missing or expired documents, package not submitted in one PDF in order as listed on page one) will not be processed for board consideration.
 - Applications not sent to all recipients below by the closeout date will not be accepted for full consideration.

- Applicants who submit their signed fitness score card MUST also submit their full myFitness history as per above.
- Applicants must furnish the required documentation as specified in the announcement. If vMPF/MILPDS RIP or current
 Branch equivalent document doesn't provide the correct data to qualify for the announcement (ie. SEI, AFSC or
 Education/PME requirement), please submit a completed AF2096, degree awarded transcript or PME certificate in the
 application annotating qualification. If required information is not provided, consideration will not be given in the qualification
 process. Optional documents not specified above can be included for consideration. Additional documents will not be
 received by our office AFTER the closing date of the announcement.
- Memorandum for Record (MFR) will only be accepted for applicants annotating being separated from the military for Nationwide announcements and providing justification of being unable to provide all required documents.
- Applicants unable to provide 3 evaluations due to any reason (ie. due to date joining the military, rank prevents having 3, missing eval due to admin reasons etc.) must provide the specific reasoning on 1 DAF Form 77 Letter of Evaluation as annotated above. Parts I-IV must be completed; the justification must be placed in Part IV "comments" section and member's supervisor must sign in Part V, member must sign Part VII. AMFR or not submitting evaluations will not suffice for meeting the evaluations requirement.
 - (Example: If member doesn't have any evaluations or has only 1 or 2 required evaluations to submit, then 1 DAF Form 77 must be completed/signed with the justification of why the member can't submit any or only 1 or 2).
