Received your 20 Year Notification of Eligibility (20 Year Letter)



20 YEAR NOTIFICATION OF ELIGIBILITY (20 YEAR LETTER). POC: Readiness NCO or Soldier's IPERMs Record Upon receipt of your 20 Year Letter, you have several choices to make: (1) continue serving in the Army National Guard, (2) transfer to the Retired Reserves as a "Grey Area Retiree", (3) transfer to the Individual Ready Reserves (IRR



RESERVE COMPONENT SURVIVOR BENEFIT PLAN (RCSBP). POC: Retirement Service Office. Upon being notified that you qualify for Reserve retired pay, and before reaching the age 60, you are eligible to enroll in RCSBP. You are required by law to decline or defer coverage (DD Form 2656-5) during the 90 day period beginning the day your 20 year letter is generated. Those who receive their 20 year letter and do not reply within the 90 days will be automatically enrolled, by law, for the maximum coverage of dependents listed in DEERS.

SUBMIT APPLICATION FOR RETIREMENT. (MANDATORY)

POC: Readiness NCO or PSNCO. They will assist you in preparing and processing your packet. Make sure that the DA Form 4187 provided indicates the effective date you want to be transferred to the Retired Reserves.

REVIEW ALL RECORDS IN iPERMS. POC: Readiness NCO or PSNCO. Confirm the following documents are in your records: Soldier Record Board (SRB) or Officer Record Brief (ORB), DD Form 214s, Awards, DA Form 1059s, and course completion documents (40 hours or more).

REVIEW YOUR RPAM STATEMENT (NGB23B). POC: Readiness NCO or PSNCO. Review RPAM statement for any discrepancies. Provide the unit with the following documentation: DD Form 214s, previous NGB Form 23B, DA Form 1379s, LESs, proof of completed correspondence courses prior to 15 April 2016.

VERIFY REDUCED RETIREMENT AGE ELIGIBILITY. POC Readiness NCO or PSNCO. Soldiers that have participated in specific missions or deployments after 29 January 2008 may qualify.

VERIFY GEORGIA MILITARY PENSION FUND ELIGIBILITY. POC: Readiness NCO or PSNCO. **Eligibility begins at age 60.** All requests must be sent by the individual retiree 90 days prior to turning age 60 to the address provided on the Georgia Military Pension Fund Application for Retirement Allowance form. Soldiers separated from the Georgia Army National Guard (GAARNG) on or after 1 July 2002 with 20 years of military service and 15 years in the GAARNG to include the last 10 consecutive years served. The form is located at www.ers.ga.gov.

If the medical issues are not service related, it is then the responsibility of the Soldier.*

Consider Veterans Group Life Insurance. *VGLI -You must apply within one year and 120 days from discharge.
