3	Entry Physical Exam or Memo		Entry Physical Exam (2808 and 2807-1) usually from MEPS or provide a memo with an explanation detailing the reason for lack of Entry Physical Exam
4	Physical Profile completed IAW AR 40-501 (DA Form 3349)		The DA Form 3349 must list the Soldier's disqualifying medical and/or behavioral health condition(s) in block 9 and must have a second signature in block 13
5	Commanders Performance and Functional Statement (DA Form 7652, APR 2019)		Section III C must be filled out by the commander. The Battalion Commander must be a 05 or above. The commander must be a 03 or above, if not an assumption of command memo is required. The form requires a signature date.
6	MMRB/MAR2 Proceedings (If Applicable)		If applicable
7	Approved LODs with Determinations (DA Form 2173 and DD Form 261 or LOD Approval Memo)		LOD for disqualifying condition(s) only
8	VA Rating (if Applicable)		The Soldier can obtain a copy of his VA disability compensation letter by logging into his "Myhealthvet" account at <a href="https://www.myhealth.va.gov">https://www.myhealth.va.gov</a>
9	IDES or Legacy Disability Evaluation System (LDES) (DA Form 4856, MAR 2023)		Verify whether the SM has a VA Rating, Complete part IV (SM makes an election and sign), LDES memos are required if the SM elects LDES and all signature dates must match the form date
10	Previous MEB/PEB Decisions (If applicable)		If applicable
11	Last 3 evaluation reports (OER/NCOER/ E-4 Word Picture)		Provide a memo with an explanation detailing the reason for missing any of the last three evaluations
12	Current ORB/ERB		Ensure the form(s) is generated within 60 days
13	LES- Current end of month (DFAS Form 702)		Ensure the form is generated within 30 days
14	Following orders (Attachment/Extension/Mobilization/ ADME/MRP-E/MRP/CCU/AGR)		Submit orders in chronological order as one attachment
15	Promotion/Demotion orders within last 2 years (If applicable)		If applicable
16	DD Form 214/ DD Form 220/DD Form 215/NGB-22		You need the following when: DD 214- SM is on consecutive orders for 90 days or more DD 215- corrections are made to the DD 214 DD 220- SM is on consecutive orders for more than 30 days but less than 90 days. You can verify this with the RPAM
